During his tenure, he worked with fact-finders and mediators to resolve disputes, investigated and adjudicated charges of unfair labor practices, and recruited and managed a roster of neutrals. He also administered and conducted representation elections.

Prior to his appointment to the State Employment Relations Board, Mr. Schmidt served as Assistant General Counsel and Deputy Director of the Ohio Lottery Commission. He has also served as a Contract Attorney in the Cleveland headquarters of international law firm Squire Patton Boggs, where he helped manage complex, high-profile litigation cases.

Mr. Schmidt is a member of the American Bar Association's Dispute Resolution and Labor & Employment Law sections, the Ohio State Bar Association's Labor & Employment Law section, the Cleveland Metropolitan Bar Association's ADR and Labor & Employment Law sections, as well as the Northeast Ohio and Central Ohio chapters of the Labor and Employment Relations Association (LERA). He has published many articles about ADR in the *Cleveland Metropolitan Bar Journal* and other industry publications.
